

COST H2020/SPECIFIC GRANT AGREEMENT

- COST Association signed a seven-year' Framework Partnership Agreement (FPA) "COST H2020" and the first one-year Specific Grant Agreement with the European Commission in May last year.
 - The FPA has set the strategic Action Plan for the seven years under Horizon 2020
 - the yearly SGA describes the work to be done in order to implement that strategy and allows to receive the annual budget.







POTENTIAL COST BUDGET CUT

- European Fund for Strategic Investments (EFSI), drawing budget from Horizon 2020. Every programme participates to financing EFSI with the budget cuts being distributed unevenly through the different research programmes.
- The COST Framework is facing a budget cut as from the 2016-2017 annual budget, which would impact the number of future COST Actions and most likely lower the funds available per COST Action.
- potential 7% COST budget cut
- "the various amounts of budget cuts are currently under discussion in context of the Trilogue, elaborated data and information on the industrial dimension, standardisation and policy"
